## **RESOLUTION 2023 – 159**

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE BOROUGH OF MOUNT ARLINGTON, COUNTY OF MORRIS, STATE OF NEW JERSEY, ACCEPTING THE BID AND AWARDING THE CONTRACT FOR THE 2023 WATER AND SEWER SYSTEMS EMERGENCY REPAIR SERVICES TO TOMCO CONSTRUCTION INC.

WHEREAS, the Borough of Mount Arlington has determined that it is necessary to have water and sewer systems emergency repair services for the Borough; and

WHEREAS, the Borough of Mount Arlington advertised and accepted bids for the desired project, and on October 25, 2023, the Borough of Mount Arlington opened and reviewed three (3) bids to perform the 2023 Water and Sewer Systems Emergency Repair Services. All bids were reviewed for the following: (1) all bid prices (written) were compared with bid prices (figures) for accuracy; and (2) completion of all forms within bid documents. The lowest responsive and responsible bidder, according to the bid tabulation prepared by the Borough Engineer Mr. Matthew T. Peles, P.E., is Tomco Construction Inc.; and

WHEREAS, Borough Engineer Mr. Matthew T. Peles, P.E., in correspondence dated October 30, 2023, a copy of which is attached to the Resolution and incorporated herein by reference, recommends the Contract be awarded to Tomco Construction Inc. as the lowest responsive and responsible bidder, at a cost of \$88,976.80; and

WHEREAS, the Chief Financial Officer recommends this award on the grounds that it represents the best price available; and

WHEREAS, the Chief Financial Officer certified the availability of funds for the contract amount, not to exceed \$88,976.80.

**NOW, THEREFORE, BE IT RESOLVED,** by the Mayor and Council of the Borough of Mount Arlington, County of Morris, State of New Jersey, that the Contract for the 2023 Water and Sewer Systems Emergency Repair Services is awarded to Tomco Construction Inc.

This Resolution shall take effect immediately.
