

**Resolution 2024-96**

**RESOLUTION OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, NEW JERSEY, AUTHORIZING THE AWARD OF A CONTRACT FOR SOLID WASTE DESIGNATED RECYCLABLE MATERIALS AND VEGETATIVE WASTE COLLECTION AND DISPOSAL SERVICES TO BLUE DIAMOND DISPOSAL, INC. IN THE TOTAL BID AMOUNT OF \$2,544,000 FOR THE PERIOD OF JANUARY 1, 2025 THROUGH DECEMBER 31, 2029**

**WHEREAS**, the Borough of Mount Arlington (the “**Borough**”) sought bids for Solid Waste Designated Recyclable Materials and Vegetative Waste Collection and Disposal Services commencing January 1, 2025; and

**WHEREAS**, one (1) sealed bid was received and opened by the Borough on July 25, 2024 from Blue Diamond Disposal, Inc. (“**Blue Diamond**”); and

**WHEREAS**, upon review, the Borough desires to award Option #1, Five Year Contract to Blue Diamond in the amount of \$480,000 in Year 1, \$494,400 in Year 2, \$508,800 in Year 3, \$523,200 in Year 4, \$537,600 in Year 5, for a total bid amount of \$2,544,000, for the period of January 1, 2025 through December 31, 2029; and


**WHEREAS**, the availability of funds needed for this contract award have been certified by the Chief Financial Officer; and

**WHEREAS**, the Borough desires to authorize the award of Option #1, Five Year Contract to Blue Diamond as the only responsive and responsible bidder.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Mount Arlington, County of Morris, State of New Jersey as follows:

1. The above recitals are incorporated herein as though set forth in full.
2. The Contract for Solid Waste Designated Recyclable Materials and Vegetative Waste Collection and Disposal Services for a period from January 1, 2025 through December 31, 2029, in the total bid amount of Two Million, Five Hundred Forty-Four Thousand Dollars (\$2,544,000) is hereby awarded to Blue Diamond as the only responsive and responsible bidder.
3. The Mayor and Borough Clerk are hereby authorized and directed to execute the contract, and said officers, together with all other officers, professionals and employees of the Borough are hereby authorized and directed to take any and all steps necessary to effectuate the purposes of this Resolution.
4. This Resolution shall take effect immediately.
